How to Create an Account

1. Create an account by entering a username, e-mail address and choose business
2. You'll immediately receive an email with a link to set up your password
3. Click on the link and create your password
4. You can then log into the site and create and edit your business or community profile by clicking on the links at the top of the left column
5. After Home Base Iowa validates your information, you will receive an e-mail that your information is live on the site

About Us.

In 2014, the Iowa Legislature overwhelmingly passed the Home Base Iowa Act, which provides the following incentives: state income tax exemption on military pensions, \$5000 military homeowner assistance, permissive veteran preference in employment, streamlined occupational licensure processes and automatic in-state tuition at public universities and community colleges for qualified veterans, spouses and their dependents.

Home Base Iowa designates qualified communities as centers of opportunity for military veterans based on four standards: 10% of businesses must become HBI businesses, each community develops its own incentive package, Home Base Iowa Community Designation is proudly displayed, and the community supports a resolution of support.
